#### 1. Call to Order

#### 2. Approval of Agenda

#### **RESOLUTION NO. 850**

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF PUBLIC UTILITY DISTRICT NO. 1 OF WHATCOM COUNTY APPOINTING AN INTERIM COMMISSIONER TO REPRESENT PUBLIC UTILITY DISTRICT NO. 1 OF WHATCOM COUNTY (DISTRICT).

**WHEREAS**, Public Utility District No. 1 of Whatcom County (District) is a special purpose district established under the laws of the State of Washington; and

**WHEREAS**, the PUD Board of Commissioners is comprised of three District Commissioners, one from each District comprising the PUD District; and

**WHEREAS**, the District 1 PUD Commissioner position has been vacant since May 1, 2024 following the resignation of the elected Commissioner; and

WHEREAS, RCW 54.12.010(5) and RCW 42.12.080 provide that when one vacant position of an elected nonpartisan governing body of a special purpose district such as the District is vacant, the remaining members of the governing body shall, after publication of the vacancy and call for nominees as required by RCW 42.12.080(1), appoint a qualified person to fill the vacant position to serve until the next general election and the election of a new Commissioner for the remaining term of the District 1 Commission position; and

**WHEREAS**, RCW 54.12.010 (3) provides that a qualified person is a registered voter who resides in PUD Commission District No. 1; and

**WHEREAS**, pursuant to RCW 42.12.080(1), the District advertised for candidates to fill the vacant position for District 1 PUD Commissioner from May 3, 2024 through May 20, 2024; and

WHEREAS, Mr. \_\_\_\_\_\_ submitted his candidacy for the position, has represented that he is a registered voter residing in PUD District 1 as required by RCW 54.12.010(3), was interviewed by the Board of Commissioners on this date at a duly noticed special meeting of the Commission, and the Commission found him to be qualified to fill the term of District 1 PUD Commissioner until the next general election in November 2024 is certified by the Whatcom County Auditor.
